Lying to in transport area throughout the remainder of the day and night and continued discharging cargo into boats as they became available returning from the beach. Comdr. G. W. McCORNICK, D-M, U.S.N.R., temporarily detached this date for temporary duty as ComTransGroup Beachmaster on staff of ComTaskGroup 53.4, Captain J. B. McGOVERN, U.S.S. ZEILIN.

Opened flooding valves to forward magazine to supress fire hazard. 0922 Closed flooding valve to forward magazine and pumped out same.
