0800 09-32 North 127-47 East 1200 09-44 North 127-16 East 2000 10-11 North 126-51 East

At sea in company with Task Force 78. 0104 Pagbabacnan Point, Homonhon Island, temporarily lighted beacon abeam to starboard, distant 11.8 miles. 0135 Desolation Point, Dinagat Island, temporarily lighted beacon abeam to port, distant 2.5 miles, passed through extreme southern portion of Suriagao Straits due to enemy mine field reported to the northward; entered Leyte Gulf. 0205 Task Group 78.3 parted company with this disposition and proceeded on assigned mission. 0515 Observed gunfire and star shells ahead in the direction of San Pedro Bay. 0525 All hands at general quarters. 0615 Enemy aircraft sighted bearing 1750 True, distant 6,000 yards, position angle 250; heavy antiaircraft fire opened by units of the screen. 0630 Contact lost with enemy aircraft, antiaircraft fire ceased. 0639 Sighted floating mine two points on starboard bow, distant approximately 2,000 yards. 0649 Passed floating mine to starboard. distant 500 yards; P.C. 1129 circled mine and attempted to destroy same by automatic weapon gunfire. 0719 Set condition One Able. 0739 Mariquit@aquit Island light house abeam to starboard, distant 1.5 miles; entered San Pedro Bay and approaching assigned anchorage. 0801 Lowered all boats. 0815 Anchored in 13 fathoms of water, 14,000 yards off Palo beach, Leyte Island. 0831 All boats in the water, commenced debarking troops. 0855 All troops boated and away to rendezvous area. 0905 LCM's from this vessel in fifth wave dispatched to line of departure. 0925 Seventh wave dispatched to line of departure (first wave from this vessel); eighth, minth and tenth waves dispatched at five minute intervals. 0940 All waves dispatched, made preparations to discharge cargo, "H" hour, 1000 first wave of boats landed on the beach, reported fairly heavy resistance. 1100 Hove up anchor and proceeded to close beach to 6,000 yards to expedite unloading. 1107 Commenced discharging cargo, first boats returned from the beach. 1213 Anchored 6,300 yards off Palo beach in 9 fathoms of water. 1603 All hands at general quarters, condition red, enemy aircraft approaching. 1644 Condition white, all clear, secured from general quarters. 1721 All boats hoisted aboard, making preparations to proceed to sea. Secured from condition One Able, set condition III. 1750 Hove up anchor and proceeded from San Pedro Bay towards Leyte Gulf in company with Transport Division SIX. 1825 All hands at general quarters, enemy aircraft approaching. LCI units layed smoke screen around transport area. 1843 Various units opened fire with intense antiaircraft barrage. 1909 Set condition III, all clear. 1935 Mariquitdaquit Island abeam to port, distant 2.3 miles, entered Leyte Gulf. 2145 Dense smoke haze settled in Leyte Gulf, visibility 500 yards. 2150 Transport Division TWENTY -FOUR joined formation and proceeded in company towards Surigao Straits. 2330 Dense smoke haze continued, visibility 200 yards. Keeping station and obtaining position fixes by S.G. radar.

21 Oct. Steaming in Leyte Gulf and proceeding to seaward in company with Transport Division SIX and TWENTY-FOUR. 0228 Passed out of Leyte Gulf, Desolation Point, Dinagat Island abeam to starboard, distant 1.5 miles. 0335 Rendezvoused with units of Task Group 78.3, Transport Divisions TWENTY, THIRTY-TWO and FOUR. U.S.S. HUGHES, ComTaskGroup 78.3 assumed tactical command. At sea throughout the remainder of the day steaming in company with Task Group 78.3.
